ROLPH AND BOYD FAMILIES CREATE A LASTING EXPRESSION OF CARE

Friends of the Northumberland Hills Hospital Foundation now have a new opportunity to support health care in the community.

On June 21st, the Foundation announced the creation of an Endowment Fund to support capital equipment purchases and programs at the hospital. An Endowment Fund is an investment fund that is set aside to provide a source of long-term support for the hospital. Only the investment income earned, or a portion thereof, is annually disbursed. The principal is preserved intact.

Creating an endowment provides permanent financial support to the hospital.

Additionally, for a minimum gift of \$25,000, it is now possible to honour the memory of a loved one or pay tribute to a family or colleague through the creation of a Named Endowment Fund. A Named Endowment Fund becomes a lasting symbol of the bond between the hospital and those who are permanently honoured.

The Foundation is delighted to announce that at the launch of the program, two Named Endowment Funds have recently been established.

THE ROLPH FAMILY ENDOWMENT FUND

The Rolph Family Endowment Fund was established by Jaffray (Jeff) Rolph to honour his family and pay tribute to a long-standing tradition of service to the community.

Mr. Rolph has been active in the support of his community throughout his 60 years of residence in the Cobourg and Hope Township area including service on Cobourg Town Council, Founding President of the Cobourg Branch, Canadian Cancer So-

ciety, being active on a number of fundraising committees including the drive to build the C. Gordon King Centre, Cobourg YMCA and the Northumberland Hills Hospital.

Prior to her death in 1994, Mr. Rolph's mother, Dorothy, was a former Director of Volunteers at the former Cobourg and District General Hospital.

Mr. Rolph is predeceased by his son Robert and wife Judith. He has four children, Victoria, Greg, Janet and Lesley, 9 grandchildren and one great grandchild. He is presently married to Carol.

FOUNDATION ENJOYS SPECIAL GIFTS FROM A SPECIAL LADY

July 13th, 1996 is a day that Carol Lawrence will never forget. That was the day her husband, Tom, was diagnosed with prostate cancer.

Tom Lawrence was a man who was larger than life. His love of playing sports, his love for his family and friends and his zest for living touched all those who knew Tom. Unfortunately, prostate cancer also touched him at a time when retirement was to be golden.

Because Tom was so strong and healthy at the time of his diagnosis, his physician suggested that he would be a perfect candidate to have his prostate removed. It was during this surgery that it was discovered the cancer had spread to his lymphnodes. The surgery was discontinued and the Lawrences were told Tom would only live for another 2 – 2 1/2 years. Carol was quick to point out that Tom was very determined in his fight against cancer. He chose to undergo various treatments, even participating in any clinical trials available which extended his life a further two years. Tom passed away on June 12, 2000.

During his illness, Tom and Carol became regular visitors to the hospital –

Tom for his blood transfusions and Carol as his Number One supporter. Near the end of his life, Tom spent six weeks as a patient in the hospital.

"Tom had a wonderful hospital experience. Everyone was so good to him, to me too for that matter," states Carol. "Of course, I think the hospital staff would consider Tom to be a remarkable patient too. He knew he was dying, yet he always had a positive attitude."

On many occasions, Tom told Carol that he was going to write a letter to the hospital management to tell them how grateful he was for his professional care, and to acknowledge the nursing staff. Sadly, this was a letter that Tom never got around to writing.

Carol has never forgotten that the hospital was there for her and Tom at a time when they needed care. While Tom may never have had a chance to write a letter of thanks, Carol has made her appreciation known, and for the past several years, she has made special gifts in remembrance of Tom.

The hospital is very grateful to Carol, and wishes to recognize her for the support she has extended to touch the lives of other patients that we serve.

LEAVING A LEGACY TO THE HOSPITAL

One of the most used and practical ways of benefiting a charity is by way of a bequest in your Will.

There are considerable benefits which are as follows:

- the bequest is made upon your death such that it does not use income during your lifetime.
- your estate will receive a tax receipt.
- it obviously benefits the charity.
- you may be in a position to give a larger bequest than you could during your lifetime.

There are a number of ways that you can implement your various bequests.

- a specific amount of money can be set out in your Will.
- you may bequest stocks in publicly held companies. This can also be advantageous from an income tax point of view but you should definitely check with your accountant concerning any income tax ramifications.
- it is possible to leave a percentage of your estate to a charity.

- in some cases you may wish to make the charity an alternate beneficiary in your Will. In other words, you can leave a bequest to a specific person and provide in your Will that in the event of their death prior to you, their share would be left to the charity.
- You may also leave real estate, again, you should check with your accountant concerning income tax ramifications. In the event that it is your principal residence there are no capital gains to be concerned with, however, other properties may have certain tax ramifications.
- You may also wish to take advantage of the endowment fund which has been set up by the Northumberland Hills Hospital Foundation and this can be specified in your Will. Information regarding the endowment fund can be obtained directly from the Foundation.

Don't forget, that it is always possible to change your Will at any time prior to your death.
