## CHARITABLE GIFT ANNUITY A Win-Win for the Hospital and the Kurita Family



hen Peter and Miriam Kurita decided that their investment portfolio had grown to some extent larger than what they felt they needed as their "nest egg", they explored options for how they could share their good fortune.

"Our heirs all have post-secondary education and are doing quite well for themselves" states Peter. "Given their financial stability, we decided to reach out and explore options to help our community.

We looked at an outright gift to a charity of \$50,000. This gift would produce a tax receipt that would pierce the ceiling on charitable giving – only part of it would be effective for that year – plus that money would not be available to us if we decided we needed it in the future.

The answer for our family was a charitable gift annuity. If you place that same \$50,000 into a charitable gift annuity, you give that money to the charity and they will buy an annuity from that amount on your behalf. Since the annuity will cost 75% of the \$50,000, the charity is able to keep 25% for immediate use and the donor receives an income tax receipt for this amount.

Currently annuities pay somewhere near 8%, therefore 8% of \$50,000 = \$4,000 which will be received by the donor on an annual basis. Further, if you are over age 75, over 90% of that annual amount will be received tax-free."

Recently, Peter and Miriam both set up charitable gift annuities in support of the Northumberland Hills Hospital. The hospital family wishes to express sincerest thanks to the Kurita's for their generosity.

The charitable gift annuity is a win-win for both the donor and the charity.

An example of what this means to the donor would be: for those who purchased shares of a stock at \$30/share, and the current price is \$80/share, if the shares were donated to a charitable organization, the donor would pay no tax on the \$50/share gain, whereas before, there would have been 25% tax to pay on the gain.

Due to this new ruling, it has been estimated by economists that in excess of \$100 million dollars in additional funding would be provided to various organizations across Canada. This increases the opportunities for inclividuals to make an impact on their communities while saving on their tax bill.

Philanthropy is a more personal decision than ever, as donors and organizations are having closer relationships for individual areas of interest. Who could have anticipated this next announcement, in the last week of May, when the Tanenbaum family of Toronto became the first major donor to use this new tax rule by donating a \$50 million gift of stock. The Mount Sinai Hospital in Toronto was the beneficiary of half of this extraordinary donation. Mr. Tanenbaum and his family have forged a close bond with the Hospital over the years and are very much involved with supporting its programs and furthering its mission.

If you are thinking of making a donation to the NHH—this can be a win-win. You are able to honour your wish and save significant taxes in the process.

he Foundation is honoured to announce that long-time Cobourg physician, Dr. Bob Scott, and his wife Ann have established an endowment to help purchase medical equipment for the benefit of community patients.

Details of the endowment fund were announced during a reception after Dr. Scott was honoured as the recipient of the Ontario Medical Association's prestigious Glenn Sawyer Service Award.

The Scott's have been residents of the Cobourg area for 40 years. In 1966, Dr. Scott joined Dr. Jack Leeson in practice at the Cobourg Medical Centre and worked out of the local hospital until his retirement in 1997. Both Bob and Ann have worked tirelessly over the years in support of Rotary International's campaign to eradicate polio globally.

The Scott's feel that whenever one is active-

ly fundraising for any cause close to one's heart, they must lead by example. To this end, they have made this gift to the Foundation. The gift is for the benefit of the entire community as the interest earned on the fund annually will be directed towards purchasing items on the hospital's priority equipment list.

Endowment funds are permanently held and can be added to at any time in the future; the capital (donor's contribution) is preserved and held in perpetuity, generating income year after year. The income from the investment is distributed annually to the hospital for the designated purpose.

A gift towards endowment can provide opportunities that go on forever...it is the gift that keeps giving.

n May 9th, members of the Foundation Board and several invited guests participated in a full day strategic planning workshop designed to look at what the future holds for local healthcare and plan accordingly.

The Foundation exists to support the capital equipment needs, special projects, and programs that help our professional staff care for you.

This is an awesome responsibility and board members want to make sure that we have a plan in place to help us reach our goals. We know that it's inevitable that the CT scan will require upgrading, that an MRI will one day be in service here in Northumberland and that the millions of dollars in equipment we purchased at the time of our move to this new facility will require upgrading and replacing. Technology is rapidly changing and we must continue to move forward at a reasonable pace to stay current.

To do so, planning is required. We will soon have a plan in place that will look three to five years into the future and identify key priorities that we must focus on to ensure that we live up to our potential. Our community's health depends on this.
