# A Message from the Executive Director EXTRAORDINARY GIFTS FROM AN EXTRAORDINARY COMMUNITY

t's not often that I personally submit a story to the newsletter to share with our donors, but I couldn't let the opportunity to highlight some of the exciting gifts/events that have happened in the last two months pass without great fanfare.

The months of July and August were

banner months for donations. Recognizing the need to update the hospital's existing CT scanner, an ambitious effort was launched to visit all five municipal councils to ask for financial support. Our goal was to raise \$1 million. At this writing, the Municipalities of Port Hope and Cobourg have

each confirmed gifts of **\$300,000**, the Township of Cramahe has confirmed a gift of **\$100,000** and we expect to hear back from the Township of Hamilton and Municipality of Alnwick/Haldimand in the new year. At each of these presentations we were warmly welcomed and this provided our volunteers with the momentum to continue on in the

# CHARITABLE GIVING

he desire to leave a legacy is part of the human condition. If you wish to leave your mark on the world by contributing to a worthy cause, there are many options available to you.

#### GIFT OF A LIFE INSURANCE POLICY

Did you know that a gift of life insurance benefits is a way of making a gift without depleting your estate or depriving your loved ones of other assets? The main advantage of using life insurance as a gift is that ultimately, the value of the insurance benefits payable to the charity will be substantially greater than what you paid for the policy. The policy can be paid for with small regular payments out of your current income rather than your assets. Upon your death, your gift of the policy benefits will be paid by the insurance company directly to your named charity. Since the proceeds do not form part of your estate, there are no probate or administration fees and creditors or family members cannot contest your gift.

Upon your death, the charity will provide your estate with a charitable tax receipt for the amount of the death benefit. Your estate then benefits from a tax credit based on the marginal tax rate of the estate (usually around 50%), which will reduce your net taxable income for two years.

Another method of donating a gift of life insurance involves changing the beneficiary and owner of your existing policy to your chosen charity. The charity would issue you a charitable receipt for the cash surrender value of the policy and any accumulated dividends. In addition, any premiums that you continue to pay on this policy will be considered a charitable donation and thus you will be provided with charitable receipts in each year that you pay the premiums. The resulting tax credits can effectively halve the cost of the insurance to you, while your chosen charity will still receive the full benefit of the policy.

However, it is important to remember that the value of the policy will be considered income in the year that ownership changes. While the charitable tax receipt will offset the tax owing on your income, your eligibility for any meanstested social programs that you are registered in will be affected by the sudden "increase" in your income. Hence, changing ownership of your life insurance policy is not something you want to undertake without careful professional advice and consideration.

### GREAT CARE PROMPTS SPECIAL GIFT

he Foundation was recently the recipient of a special gift from R.M. (Mo) and Theresa Howe. In the past few years, Mo has been a patient in the hospital where "he's always received such good care", Theresa points out. In mid-September the Howe's celebrated 60 years of marriage. Instead of buying each other a gift to commemorate this special occasion, the Howe's were prompted to investigate what opportunities the hospital had for making a contribution.
