LHIN BOARD RECEIVES HOSPITAL REVIEW REPORT Hospital Improvement Plan to be submitted in December

The Board of the Central East Local Health Integration Network (Central East LHIN) held their monthly open board meeting in Oshawa on October 28th where they passed a motion related to the Northumberland Hills Hospital – External Operational Review.

Based on information presented by Stewart Sutley, the LHIN's Senior Director of System Finance and Performance Management, the motion directs the hospital to return to the LHIN Board in December with an NHH Board-approved Hospital Improvement Plan.

This is the latest step in a process that began in August 2014 when the hospital advised the LHIN of a projected in-year deficit which, under the current Hospital Service Accountability Agreement (HSAA) between the hospital and the LHIN, led to notice of a performance factor resulting in a Coaching Review in December 2014 and the External Operational Review in July 2015.

The External Operational Review conducted by the Hay Group, an independent third party, concluded that while the hospital provides quality services, is efficient and has a high functioning Board, there are areas that could be further improved that should be included in a Hospital Improvement Plan to ensure that the hospital can balance its budget and become financially sustainable.

The review did not recommend any change in the volume or types of services currently being provided at NHH.

Recommendations related to operational and clinical efficiency improvements, integration and revenue maximization were included in the report with the understanding that LHIN support will be required in order to deliver on some of the longer-term recommendations.

A proposed Hospital Improvement Plan, contained in the External Operational Review Report, incorporates the recommendations, suggested timelines and an implementation strategy which NHH can now use to develop their own plan.

- This included face-to-face meetings with local elected officials, focus groups with foundation and auxiliary members, interviews with other acute and community-based health service providers in the LHIN and a series of public and telephone town halls with local residents, supported by a paper and web-enabled survey.
