2016 Public Sector Salary Disclosure

NORTHUMBERLAND COUNTY, Friday, March 31, 2017—The Ontario Ministry of Finance has released its annual Public Sector Salary Disclosure (PSSD) list, also known as the "Sunshine List." See link here to the Ministry's full report.

First published in 1996, the list is produced annually by the Government of Ontario to provide taxpayers with the names, positions and salaries of those in the public sectors who earned more than \$100,000 in salary and taxable benefits during the previous calendar year.

Hospitals are among the sectors covered by the *Public Sector Salary Disclosure Act*. Also included are colleges, municipalities and school boards.

In 2016, 19 Northumberland Hills Hospital (NHH) employees were reported on the PSSD list. An additional two individuals employed in regional roles by Seniors Care Network (previously known as the Central East Regional Specialized Geriatric Services, or RSGS) were also reported on NHH's PSSD list. Per agreement with the Central East Local Health Integration Network (Central East LHIN), NHH acts as the paymaster for this organization which is based at NHH but serves the entire Central East region.

"Our hospital is committed to transparency and accountability," said NHH Board Chair Jack Russell. "As volunteer hospital governors, our Board takes its responsibility for setting executive compensation very seriously. In addition to specific salary requirements set out in recent years by the Ministry of Health, we take multiple factors into account, including current market standards and hospital-specific requirements, to recruit and retain the leadership experience and talent required to provide direction for the clinical services our community requires."

"NHH's 2016 PSSD list includes senior administrators, a mix of front-line care providers—registered nurses (RNs and RPNs), a nurse practitioner and diagnostic imaging specialists—as well as several regional leaders based at NHH," confirmed Linda Davis, President and Chief Executive Officer. "NHH values the work of all employees. Attracting and retaining talented and committed individuals is essential to our ability to continue to deliver the high quality and increasingly complex care required by the patients we serve. Hospitals are managing increasing pressures in various areas today, such as the heightened capacity issues that continue to be seen here in Northumberland and across the province. Even as these challenges grow, our leaders are helping to lead and facilitate the large-scale changes being implemented to transform Ontario's health care system."
